

RESIDENTIAL & COMMERCIAL RATES: (Properties with greater than 1” meter size)

To establish water fixed charge for meter sizes greater than 1” in size, the meter equivalent multiplier is multiplied by the annual fixed rate. Sewer fixed charges remain constant. Commodity charges, as noted above, are added based on metered consumption.

2020 PARK FEES

Athletic fields or facilities rented by a team or league on a per time basis or for a whole season are subject to Minnesota State sales tax. Rentals of buildings, rooms, picnic shelters and other similar structures for weddings, meetings, reunions, parties, etc. are also subject to tax. Qualifying nonprofit organizations that fully complete a certificate of exemption will be exempt from paying tax. MN State sales tax will be calculated at 7.375% of the identified rental amount. Damage deposits are not subject to sales tax.

BALLFIELD: \$250.00 damage deposit (per field)
\$75.00/day plus tax (daylight hours only)
\$100.00/day plus tax including night hours requiring lighting

PICNIC SHELTER: \$50.00 damage deposit
\$25.00 plus tax for private use reservation (includes electricity)

For the Picnic Shelter; an additional fee may be charged if extra set-up is required of the Public Works Department such as water source, picnic tables moved, extra sanitary or garbage service provided, or any other special requests.

VOLLEYBALL: \$25.00 damage deposit
\$25.00 plus tax for private use reservation

CONCESSION STAND: \$50.00 damage deposit
\$15.00/day plus tax (only prepackaged food & beverages may be served)

COUNCIL CHAMBERS: \$100.00 damage deposit
\$25.00 plus tax

HOCKEY RINK OPEN SKATING:

Open skating on the hockey rink is open to the public on a first-come, first-serve basis Thursdays through Mondays. Teams have no precedence over any groups or individuals that may occupy the rink DURING NON-SCHEDULED times. Team practice sessions will only be reserved and scheduled on Tuesdays and Wednesdays from 5 – 10 p.m. All skaters must be off the ice by 10:00 p.m.

All teams: Fees for Hockey Rink use must be made in advance by either cash, money order or cashier's check.

FIELD USE CHARGES FOR SOFTBALL AND BASEBALL LEAGUES

Athletic fields or facilities rented by a team or league on a per time basis or for a whole season are subject to Minnesota State sales tax. Rentals of buildings, rooms, picnic shelters and other similar structures for weddings, meetings, reunions, parties, etc. are also subject to tax. Qualifying nonprofit organizations that fully complete a certificate of exemption will be exempt from paying tax. MN State sales tax will be calculated at 7.375% of the identified rental amount. Damage deposits are not subject to sales tax.

SOFTBALL TEAMS:

Each **MEN'S** softball team will pay a fee of **\$400.00** to the City of Zimmerman. This fee will be paid to the City two weeks prior to the season's start, and shall include a schedule of games to be played and any tournament scheduling.

Each **WOMEN'S** softball team will pay a fee of **\$325.00** to the City of Zimmerman. This fee will be paid to the City two weeks prior to the season's start, and shall include a schedule of games to be played and any tournament scheduling.

FALL CO-REC SOFTBALL league players will pay a fee of **\$150.00** per TEAM. Fees will be paid prior to season's start, and shall include a schedule of games to be played and any tournament scheduling.

BASEBALL TEAMS:

Each baseball team will pay a fee of **\$150.00** to the City of Zimmerman. This fee will be paid two weeks prior to the season's start, and shall include a schedule of games to be played and any tournament scheduling.

PRACTICE TIMES:

Practicing on either baseball or softball fields is open to teams on a first-come, first-serve basis. Teams have no precedence over any civic or social group that may occupy the field **DURING NON-SCHEDULED** times. Community Recreation, Youth Baseball and other groups are also scheduled to use the fields. If a team wants to schedule practice sessions, they may register at City Hall and pay the appropriate fees for field use.

FIELD USE CHARGES FOR YOUTH ATHLETIC TEAMS, LEAGUES AND ASSOCIATIONS:

Each youth athletic team, league or association will pay a fee of **\$7.50** per participant to the City of Zimmerman for field use. Each team, league or association shall report the number of participants to the City prior to using the facilities. The City shall invoice each team, league or association for the field use fee. This fee does not apply to hockey rink rental. Hockey rink will be rented out at an hourly rate as identified under 2020 Park Fees.

All teams: Fees for Ball field use payments will be made in either cash, money order or cashier's check.
